General Instructions:

1) Negative Marking System: For This exam there is ¼ Negative Marking System. It means if you make one answer wrong then you will be deducted 0.25 marks from right once if question is for 1 marks and 0.50 marks deduction if question is of 2 marks.

2) Prelim exam is combined means you will appear for one paper but results will be three. It means while applying for exam either you can apply for ASO or STI or PSI alone. You can apply for all posts together or you can apply for 2 posts together. So, accordingly they will treat you for result.

3) Mains exam is mixed. It means the paper 1 of mains will be same across three post on one day same time same paper. If you are qualified for ASO mains only then your paper 1 marks will be added to ASO final result only. Like this if you are qualified for ASO and STI mains too then your paper 1 marks will same for ASO and STI.

4) Paper 2 of mains is separate for each ASO, STI and PSI respectively. Like this result will be separate for each. For PSI there are two more phases 1.Ground Test of 100 marks and
2.Interview of 40 Marks. There are no interviews for ASO and STI. Neither Typing is required for any of these three posts but for PSI there is Physical Standards for eligibilities.(mpscmaterial)

5) There may have mistakes from my side. But, the overall syllabus is correct! You can request this .docx for personal use only for corrections if you want.

6) Always keep original Marathi syllabus with you. You will get familiar with Marathi syllabus soon. You must be good in Marathi, there are 100 marks(1/4) out of 400 marks for it.
